Millis Public Library Board of Trustees Meeting Minutes

Tuesday, June 5, 2023

Call to Order:

Ms. Farrar, the Chair, called the meeting to order at 7:05pm with Trustees Tricia Berube and Laura Satta and Library Director Kim Tolson and Youth Services Librarian Rachel Silverman present

Minutes for the May 16, 2023 meeting passed unanimously

Ms, Tolson presented the Director's report, noting that she was monitoring the budget for any changes in materials expenditure as the materials budget was not increase in step with the personnel cost increases. We will plan to address at town meetings.

Ms. Tolson reported that the lighting replacement project is complete. The new lighting system has wall switches as well as app-based controls. For coverage she has set Rachel up with it and am trying to get John Engler on as an Admin as well

Ms Tolson shared highlights of recent programs and services. Noteworthy is that Girls Who Code is wrapping up the current session and will hold its final meeting on Wednesday, 6/7. The four girls in the club worked hard this year learning/improving coding in HTML and building their group project, which is a website reviewing and highlighting local attractions (restaurants, amusements, etc).

Ms. Tolson confirmed that everything is in place for Rachel to step into role as Acting Director. Rachel will communicate any alarms or issues in the building to the trustees. Ms. Tolson confirmed there is a typically available manual of protocols for the library of staff for issues that may arise
